

FS-3500 Floor Stripper


Description

The Ohm-Shield™ FS-3500 Floor Stripper is a concentrate designed to safely and effectively remove multi-layers of floor finish and dirt. It is recommended to use floor stripper when first applying static dissipative floor finish to ensure long lasting floor finish adhesion.

When floor finish is properly applied to a clean floor it lasts longer, is easier to maintain, has ultra glossy shine and improved ESD performance.

Ohm-Shield™ FS-3500 has a low odor, safe solvent and surfactant system. It does not contain ammonia or phosphate. Coverage is approximately 10,000 - 15,000 sq. ft./gal. diluted. FS-3500 should be diluted 4:1.

FS-3500 is available in 1, 5, and 55 gallon containers.

When using Ohm-Shield™ FS-3500, care must be used in handling the product. Rinse all residual stripper solution with neutralizer and on two flood washes of plain water.
